

Аннотация

Влияние антисоциальных черт личности на насильтственные установки студентов: аннотация к дипломной работе / Анастасия Андреевна Чурай; БГУ, факультет философии и социальных наук, кафедра социальной и организационной психологии; науч. рук. И.А. Фурманов. Дипломная работа включает оглавление, перечень условных обозначений, реферат, введение, две главы, заключение, список использованных источников и приложения. Общий объем работы — 75 страниц, включая 4 рисунка, 1 таблицу, 2 приложения, 107 источников.

Ключевые слова: АНТИСОЦИАЛЬНЫЕ ЧЕРТЫ ЛИЧНОСТИ, НАСИЛЬСТВЕННЫЕ УСТАНОВКИ, СТУДЕНТЫ, НАСИЛИЕ, ПСИХОЛОГИЯ ЛИЧНОСТИ, СОЦИАЛЬНАЯ ПСИХОЛОГИЯ, ТЕМНАЯ ТРИАДА.

Объект исследования — насильтственные установки студентов.

Предмет исследования — влияние антисоциальных черт личности на насильтственные установки студентов.

Цель исследования — установить влияние антисоциальных черт личности на насильтственные установки студентов.

Методы исследования: опросный метод, статистический анализ (методика «Опросник насильтственных установок», опросник «Темная дюжина»).

В дипломной работе рассматривается взаимосвязь антисоциальных черт личности и насильтственных установок студентов, выявляются половые различия в выраженности этих показателей и их взаимовлияния. Установлено, что выраженные антисоциальные черты связаны с более высокими уровнями принятия насилия. Работа опирается на концепцию Темной триады и применяет современные методики диагностики.

Научная новизна заключается в одновременном анализе структуры и взаимосвязи черт Темной триады и установки на насилие у студентов с учетом гендерных различий.

Дипломная работа является самостоятельным научным исследованием автора, оригинальность составила 66,15%.

Практическая значимость работы состоит в возможности применения полученных результатов в образовательной и коррекционной практике, а также в преподавании дисциплин по психологии личности, девиантного поведения и криминальной психологии.

Уплыў антысацыяльных рыс асобы на гвалтоўныя ўстаноўкі студэнтаў: рэферат да дыпломнай работы / Анастасія Андрэеўна Чурай; БДУ, факультэт філософіі і сацыяльных навук, кафедра сацыяльнай і організацыйнай псіхалогіі; навуковы кіраўнік: І.А. Фурманаў.

Дыпломная работа ўключае змест, пералік умоўных абазначэнняў, рэферат, уводзіны, дзве главы, заключэнне, спіс літаратуры і дадаткі.

Агульны аб'ём — 75 старонак, у тым ліку 4 малюнкі, 1 табліца, 2 дадаткі, 107 крэйніц.

Прадмет даследавання – уплыў антысацыяльных рыс асобы на гвалтоўныя ўстаноўкі студэнтаў.

Мэта даследавання – усталяваць уплыў антысацыяльных рыс асобы на гвалтоўныя ўстаноўкі студэнтаў.

Метады: аптыальны метад, статыстычны аналіз (аптыальнік «Гвалтоўныя ўстаноўкі», аптыальнік «Цёмная Дюжына»).

У працы разглядаецца ўзаемасувязь антысацыяльных рыс асобы і гвалтоўных установак студэнтаў, выяўляюцца палавыя адрозненні у іх выражанасці і ўзаемадзеянні. Вынікі сведчаць, што выражаныя антысацыяльныя рысы звязаны з больш высокім узроўнем прыняцця гвалту. Даследаванне заснавана на канцепцыі Цёмнай трыяды і выкарыстоўвае сучасныя метады дыягностыкі.

Навуковая навізна – адначасовы аналіз структуры і ўзаемасувязі рысаў Цёмнай трыяды і гвалтоўных установак з улікам гендарных адрозненняў.

Дыпломная работа з'яўляецца самастойным навуковым даследаваннем аўтара, узровень арыгінальнасці складае 66,15%.

Практычна значнасць – магчымасць выкарыстання вынікаў у адукатыўнай і карэктывнай практицы, а таксама пры выкладанні дысцыплін па псіхалогіі асобы, дэвіянтных паводзінах і крымінальнай псіхалогії.

The object of the research – students' violent attitudes.

The subject of the research – the influence of antisocial personality traits on violent personality attitudes.

The purpose of the research – to determine the influence of antisocial personality traits on students' violent attitudes.

Methods of research: survey method, statistical analysis (Violent Attitudes Questionnaire, Dark Dozen Questionnaire).

The thesis explores the relationship between antisocial traits and violent attitudes among students, identifying gender differences in expression and interaction. The findings confirm that stronger antisocial traits are associated with higher levels of violent attitudes. The study is grounded in the Dark Triad concept and utilizes modern diagnostic tools.

Scientific novelty lies in the simultaneous analysis of the structure and interrelation of Dark Triad traits and violent attitudes among students, taking gender differences into account.

The thesis is an independent scientific research of the author, the originality score is 66,15%.

Practical significance lies in the applicability of the results in educational and correctional practices, as well as in teaching courses on personality psychology, deviant behavior, and criminal psychology.
